**2020-2021 Tuition and Fees**

**New Student Application Fee**

- \$75 per-application fee for grades Kindergarten through 12
- \$40 per-application fee for pre-school and pre-kindergarten
- Application fee is non-refundable and is due at time of online application submission

**Annual Registration Fee**

- The registration fee guarantees a space in the 2020-2021 school year and is nonrefundable
- Tuition accounts must be current before registration will be accepted for the upcoming school year
- Registration Fee is due May 1 for current families

Grade	Registration Fee
Preschool/Pre-Kindergarten	\$200/student
Elementary (K-5 <sup>th</sup> grade)	\$350/student
Middle School (6 <sup>th</sup> -8 <sup>th</sup> grade)	\$450/student
High School (9 <sup>th</sup> -12 <sup>th</sup> grade)	\$600/student

Grade Level	Tuition Amount
Pre-School/Pre-Kindergarten (3 day)	\$3,158
Elementary (Full K – 5 <sup>th</sup> grade)	\$6,495
Middle School (6 <sup>th</sup> – 8 <sup>th</sup> grade)	\$8,209
High School (9 <sup>th</sup> – 12 <sup>th</sup> grade)	\$9,777

**Discounts**

- Payment in Full Discount – A 2% discount is extended if tuition is paid in full by June 20 (Families enrolling after July 1 – please inquire with our tuition bookkeeper whether discount is available)
- Pastoral Discount - Grace Cascade Christian Schools provides a 10% tuition discount to qualifying pastors

**Payment Plans**

- Payment plans are available through FACTS, a third-party tuition management company, and are subject to FACTS' annual enrollment fee of \$35-per account.
- The ten-month payment plan must start in July, 2020 and ends in April, 2021; other payment plans may be available with approval; contact the tuition bookkeeper for additional information
- **Accounts must be current and in good standing to qualify for payment programs.**

**Credit/Debit Card Payment Information**

- A 2.85% non-refundable convenience fee is charged for credit/debit card payments. Credit/debit card payments must be made online via FACTS. No credit/debit card payments are accepted in the Student Offices or via telephone.

**NOTE: All students must have full registration and a minimum of one month's tuition paid, in full, prior to attending**

**WITHDRAWAL:** For students withdrawing after September 8<sup>th</sup>, tuition is pro-rated on a daily basis and a withdraw fee of 10% of the annual contract is added to the account. Any eligible refund is subject to deduction of outstanding balances, district-wide.
