New Student Application Fee

- \$80 per-application fee for grades Preschool through 12
- \$400 non-refundable tuition down payment is due at time of acceptance to secure your child's seat and will be applied towards your first month's tuition

Payment Plans (see back of page) *Once the family's annual tuition contract has been finalized*

- Payment plans are available through FACTS, a third-party tuition management company, and are subject to FACTS' non-refundable annual enrollment fee of \$55.00 per account. This is billed and paid through FACTS.
- The twelve-month payment plan starts in May 2025 and ends in April 2026; other payment plans may be available with approval; contact the tuition bookkeeper for additional information. **Your May tuition payment re-enrolls and secures your child's seat.**
- Accounts must be current and in good standing to qualify for payment programs.

Credit/Debit Card Payment Information

- A 2.95% non-refundable convenience fee is charged for credit/debit card payments. Credit/debit card payments must be made online via FACTS. No credit/debit card payments are accepted in the Student Offices or via telephone.

NOTE: All students must have a minimum of one month's tuition paid and their account current prior to attending.

WITHDRAWAL:

- **5% withdraw fee of the annual contract is charged after initial billing and payment (March-May).**
- **Withdraw fee of 10% of the annual contract is charged to the account for early withdrawal starting June 1st – September 3rd.**
- **For students withdrawing after school has begun, from September 2nd through December 31st, tuition is pro-rated on a daily basis and a withdraw fee of 10% of the annual contract is charged to the account.**
- **No refunds will be given for withdrawals after December 31st.**
- **Any eligible refund is subject to deduction of incidental expense balances, district wide.**

FACTS Management

Every family has a tuition account, incidental expense account and prepay account for their student(s) through our school management system, FACTS. Your Tuition Account is only for tuition payments, monthly as well as payment in full. Your Incidental Expense Account is used for miscellaneous charges such as Extended Enrichment Childcare, sports fees, etc. The Prepay Account is used to purchase hot lunches, miscellaneous lunchroom snack items and Challenger HQ food and drink items (high school only).

Available Tuition Payment Plans:

- **One Payment of Full Tuition**
 - Due May 15th
- **Monthly Payment Plan – Final payment must be paid by April of current school year**
 - 12 Month Payment Plan (May – April)
 - You may choose a monthly due date of the 5th or 20th for tuition payment plans.
 - You may choose to set up automatic withdraw from a checking/savings account (no additional fee) or bank card (3.05% convenience fee) for both your Tuition Account and/or your Incidental Expense Account.
 - For monthly payment plans, there is a FACTS \$55 Enrollment Fee due 10 or 20 days from when your Tuition Account is finalized.
 - You will receive a separate invoice through FACTS for this charge
 - Nonpayment of this invoice will result in FACTS terminating the tuition agreement
 - Enrollment after May 20th will require a shorter monthly payment plan. See examples below:
 - 11 Month Payment Plan (June – April)
 - 10 Month Payment Plan (July – April)
 - 9 Month Payment Plan (August – April)
 - 8 Month Payment Plan (September – April)
- **Late Enrollment**

Students who are enrolled in the Grace Cascade Christian School system after the official start of the school year will be charged the following:

 - Full tuition charged through the first two weeks of the 1st quarter
 - Tuition will be pro-rated based on the actual number of days left in the year starting the first day of the third week in the 1st quarter.
